- Student Activity Fee Budget: 2005 was the last adjustment of the student activity fee (will not increase this year - Board of Trustees are pausing fee increases)

 - a. Elementary Update Dr. Geiger for Dr. Pennypacker Hill
 - i. 10 Pre-K learners are moving up to Kindergarten early
 - ii. Pre-K through 5th grade hands-on science lab has been added this year connected to science occurring in the classroom
 - iii. 1x per week dedicated science teacher co-teaches with classroom teachers for hands-on learning
 - b. Secondary Update Dr. Geiger
 - i. Thank you for working with us on the new traffic pattern and new start time
 - ii. Tardies have gone down in secondary, middle schoolers have zero tardies
- VII. Student Government Update Destini Williams, 2024-2025 Student Body President
 - a. Club showcase was last week (set up to talk to others about clubs and sell merch
 - b. COMMITTEES: Staff Appreciation-for teachers (bday, babies, weddings); Homecoming Planning (selling tickets, scheduling and planning); Outreach (touring new students, helping with open house); Communications (social media); Athletics (pep-rally)

- VIII. Faculty Policy Council Update Gabe Lee, 24-25 FPC Chair First meeting was 9.9.2024 focusing to revamp council committees
- IX. School Improvement Plan Dr. Ross Van Boven: School subgroups are required to perform at or above 41% of students passing on state assessments (schools are identified as in need of targeted support or intervention if they fall below for 3-consecutive years, and at 6 consecutive years, schools are identified as in need of comprehensive support and intervention); Our "Students with Disabilities" subgroup had fallen below the threshold 3-years in a row; but has risen now for the past 2-years to 47% in 2022-23 and 55% to 2023-2024 moving us out of the state spotlight for low performing subgroups
- X. Programs and Procedures Manual for Exceptional Student Education Kim Dotts- Hoehnle, ESE Coordinator: Every 3-years the state requires to review the school's plan/process for identifying students with Special Needs.



PKY is unique because we don't have a continuum of services that we can provide. Typically our services are speech/language, occupational therapy, etc. 8% of our students are identified as having a disability, 12% of Elementary, 9% of Middle School, and 5% of High School students.

- XI. Balanced Calendar 2025-2026, 2026-2027, 2027-2028: Moving with the era, hoping to eliminate the "summer slide" effect.
 - a. On the new calendar: 1st day is July 28; Intercession Weeks in OCT; Running Intercessions for intervention and enrichment needs
 - b. Last day is still May 22nd
 - c. Additional communication for students/families and teacher options will follow if this is passed
 - d. Would E-learning days continue with this plan? this will need to be reviewed it is part of the current experiment that we are running now and we will need to look at that data
 - e. Why wait so long to draw up the implementation of this plan? We wanted to slow things down for planning to make sure the programming is good quality experiences for our students, especially for the intercession weeks additionally we need to negotiate faculty time, currently faculty are currently 10 month employees with UF. This has to be resolved also
 - f. BOT hasn't weighed in an opinion on the balanced calendar? We have not heard from BOT on this issue.
 - g. Is the school calendar subject to their review by BOT? Yes, they are the official school board
 - h. What were the results of the vote from last year on the balanced calendar? Majority of votes from the survey last year report yes or possibility with more info would support at 75% families and 80% faculty Approved unanimously
