All current students must re-register by October 31 to commit to attending P.K. Yonge for the next academic school year.

The annual activity fee is \$300. To re-register, all students, including those eligible for reduced Activity Fee, must pay \$150 by October 31. The \$150 is non-refundable and will be applied to the student's Activity Fee for the next academic year.

Current students who **do not submit a re-registration form with a \$150 payment by October 31** may NOT automatically be enrolled for the next school year and may be required to submit a new application to re-enter the Admissions pool.

Activity Fee:

\$300 per student per academic year, paid in advance for the next academic year (\$50 fee for late payments).

Payment 1 – October 31: \$150 | Payment 2 – April 15: \$150

For students admitted after April 16, the Activity Fee must be paid within 10 days of acceptance.

Refund Schedule:

For families accepting admission/enrollment to P.K. Yonge who have paid the full \$300 Activity Fee and later terminate admission/enrollment:

Reduced Activity Fees schedule is based on eligibility guidelines established by the Federal Free or Reduced School Meals program. Those applying for a reduced Activity Fee must submit a **2025 1040 Federal Income Tax Form** that lists the names of the children for whom the reduction is requested. If granted, the reduced Activity Fee will be adjusted per student per year to \$150.00. Families will be notified if an application for a reduced Activity Fee is successful. **Eligibility for fee reduction does not negate the \$50 late fee per student if payments are not received by the deadline.**
